STEWARDSHIP: AWS engaged community members in stewardship action, to increase awareness of the river, foster enjoyment of nature, and motivate further stewardship of the river and to restore the health of the watershed. AWS reduced pollution caused by stormwater runoff by creating rain gardens and Bayscapes in the watershed. We engaged thousands of volunteers at sites throughout the watershed to remove 24 tons of trash and recyclables and 309 tires. We engaged volunteers to plant thousands of native plants, remove invasive vegetation, and restore more than 11 acres of wetland habitat. We propagated five species of native plants in the tidal wetlands, including Wild Rice (Zizania aquatica), a historically abundant keystone species that was decimated as a result of wetland destruction and goose grazing in the last half century and that AWS has been propagating for the last decade. The recovery of marsh habitat will improve the ecological integrity of the Anacostia River and the recreational access it provides to local residents. We also continued to maintain three trash traps in the watershed, monitor the river's water quality, and investigate pollution discharges.

Environmental Education: AWS increased awareness, knowledge, skills, and a sense of stewardship among watershed residents to affect positive behavior changes for the health of the Anacostia River. AWS engaged 3,415 students in our education programs: nearly two-thirds of these students participated in hands-on classroom education, a field experience on the Anacostia River and a restoration project, such as wetland restoration, storm drain paintings, and trash cleanups. Students in our Rice Rangers program raised more than 5,000 native wetland plants in their classrooms and then transplanted them into Kingman Marsh to restore the river's wetland habitat. Nearly 500 students raised and released more than 10,000 shad fry into the Anacostia River. AWS also provided more than 100 teachers from the District of Columbia and Maryland schools with professional development and mentoring, and equipped them with content knowledge, lesson plans, and materials in order for them to incorporate environmental education and watershed concepts into their curricula. We also worked with Prince George's County Public Schools in Maryland and the Office of the State Superintendent of Education in the District of Columbia to embed environmental literacy topics into the curricula so that all children will learn about the importance of a clean, healthy Anacostia River. Through our Saturday Environmental Academy, we engaged middle school students in two 10-week semester programs, one that focused on environmental careers and the other on exploring urban parks. Lastly, we trained adults through our National Capital Region Watershed Stewards Academy to design and implement watershed restoration projects in their neighborhoods.

4 c (Code:) (Expenses \$ 224,443. including grants of \$ 0.) (Revenue \$ 92,540.)
Advocacy: AWS advocated for policies and resources that would favorably restore the Anacostia River as a swimmable and fishable river, with an emphasis on stormwater controls, reduction of trash inputs, and increased attention to the remediation of legacy toxic chemicals impacting the river. We focused on generating awareness of the issue of beverage container pollution in the river and outlining action options for individuals and policy makers in the District of Columbia and Maryland, and working with our partners and agency leaders to change the Anacostia Trash Total Maximum Daily Load (TMDL) to adequately reflect the trash problem and help establish incentives and programs needed to meet its mandate. We released our annual State of the River Report Card to raise awareness and hold those entrusted with the health of the river accountable. Although the overall grade of the Anacostia River was an "F", the report card indicated improvement on seven of the nine key indicators. The highest grade, a C+, was for the overall effort and commitment of government agencies, nonprofit organizations, and the private sector to cleanup and restore the river.
